# Notification of Intention to carry out Shot-firing

Use this form to notify of your intention to carry out shot-firing in Tasmania under an interstate shot-firing authority. This form needs to be submitted 21 days before work is to commence.

In most cases, you will also require a Security-sensitive Dangerous Substances (SSDS) permit or be a recognised responsible worker under a SSDS permit held by someone else. The Tasmanian SSDS legislation is different to interstate authorities so please check the requirements before submitting this notification.

**Exploratory** - (Category 7 geological exploration or in seismological, paleontological or other scientific research or experimentation)

**Special Operations** - (Category 8 shot-firing not covered by any other category)
