Work Health and Safety

WORK HEALTH AND SAFETY REGULATIONS 2022 CLASS EXEMPTION

Pursuant to Regulation 684 of the *Work Health and Safety Regulations 2022* (the Regulations) I, BRADLEY W PARKER, Executive Director, WorkSafe Tasmania, being the Regulator under the *Work Health and Safety Act 2012*, grant this Exemption, in specific circumstances, from some of the requirements of regulation 529D.

I am satisfied that in accordance with regulation 685, granting this Exemption will result in a standard of health and safety at the relevant workplace, or in relation to the relevant undertaking, that is at least equivalent to the standard that would have been achieved without the Exemption.

1. Commencement of Exemption

This Exemption commences on the date of gazettal in the Tasmanian Government Gazette and has effect until amended or revoked.

2. Application of Exemption

This Exemption applies to regulation 529D ‘Work involving engineered stone benchtops, panels or slabs – prohibition’, in the following circumstances:

- (i) to carry out work to reinstall an existing engineered stone benchtop, panel or slab that was temporarily removed so that other work may be undertaken at the premises.

This Exemption is a class exemption made by the Regulator on its own initiative and is subject to conditions.

3. Conditions of Exemption

In accordance with regulation 691(1) the regulator imposes the following conditions in relation to this Exemption.

1. Processing of the existing engineered stone benchtop panel or slab while uninstalled must be -
 - a. limited to:
 - i. minor modification to enable reinstallation; or
 - ii. minor repair of any damage caused during the removal; or
 - iii. minor modification of the engineered stone; and
 - b. no more significant than processing permitted for an installed engineered stone benchtop, panel or slab under regulation 529F(a)(iii).
2. If processing is required it must be controlled in accordance with regulation 529B.
3. If processing is required the relevant PCBU must notify the Regulator of the work being undertaken in accordance with the requirements under chapter 8A, part 8A.3 of the Regulations.
4. This Exemption does not apply to the re-use of engineered stone benchtops, panels or slabs or reinstallation in any location other than the location from which it was removed, including another location at the site from which it was removed.
5. This Exemption does not allow the installation of a replacement engineered stone benchtop, slab or panel if for any reason the original engineered stone benchtop, panel or slab cannot be reinstalled.

4. Exemption does not affect other requirements

Nothing in this Exemption affects any other applicable requirement imposed by law in relation to the matters to which this Exemption applies. Dated this 12th day of September 2025.

PETROLEUM (SUBMERGED LANDS) ACT 1982

OFFSHORE MINERALS ACT 1994

Delegation of Ministerial Powers and Functions under the Offshore Minerals Act 1994

WATER MANAGEMENT ACT 1999

Section 11 Exemption Order

Watercourse Authorities within Specified Irrigation Districts

I, Gavin Pearce MP, being and as the Minister for Primary Industries and Water and the Minister administering the *Water Management Act 1999* (“the Act”), acting pursuant to section 11 of the Act hereby exempt all persons who wish to convey water, that has been taken and stored pursuant to the Act, via any watercourse located within the Irrigation Districts listed below, from obtaining a Watercourse Authority under Part 6A of the Act, subject to them obtaining the prior approval of the relevant Responsible Water Entity to convey the water.

- (1) River Clyde Irrigation District
- (2) Cressy-Longford Irrigation Water District
- (3) Lake Leake/Elizabeth/Macquarie River Irrigation District
- (4) Tooms Lake/Macquarie River Irrigation District

Conveyance of water under this exemption is subject to the condition that a 10 per cent transmission loss factor is applied, or otherwise in accordance with a water conveyance plan approved by the Department of Natural Resources and Environment Tasmania.

Conveyance of water under this exemption is subject to the condition that the transmission of water is reported to the Department of Natural Resources and Environment Tasmania at Water.Operations@nre.tas.gov.au within one day of commencement of the transmission.

This exemption takes effect on 1 October 2025 and remains in force for a period of five (5) years unless otherwise revoked.

Expressions used in this exemption have the same meaning as in the Act.
