What to bring with you to Service Tasmania

- Your completed application form and the required application fee.

- Two references verifying industry experience.
- Evidence of Identity documents (these documents will be returned to you upon verification by Service Tasmania). **Please note this is only required for new applicants.** See below for a list of acceptable documents.

Evidence of identity Requirements

Before this licence application can be processed you must establish evidence of identity. To do this please provide at least:

- one document from Category A plus two documents from Category B; or
- two documents from Category A plus one document from Category B
